BEETHAM PARISH COUNCIL

MINUTES of a meeting of Beetham Parish Council held on Monday 5th November 2012 at Storth Village Church at 7.00pm.

Present were Cllrs Ken Blenkharn (chair), David Clark, Jessica Harvey, Brian Meakin, Chris Noble, Bob Pickup and Ian Stewart. Also present - Parish Clerk John Scargill. No members of the public.

- **1.0** Apologies for absence Pru Jupe (work) and Bill Haddow (Parish Steward).
- **2.0** The minutes of the previous meeting, held on 1st October 2012, had been circulated by email. These were **APPROVED** by the meeting as a correct record and signed by Cllr Harvey, who had chaired the meeting.
- 3.0 Announcements by the Chair: none.
- 4.0 Declarations of Interest by members in respect of items on this agenda none.
- 5.0 Matters arising from the minutes:
 - **5.1 Broadband (5.1)** there had been a recent meeting, attended by Cllr Clark, but details of

the precise benefits of the project for individual areas were still to be finalised.

- **5.2 Beetham Traffic Calming (5.4)** work had begun on schedule and appeared ongoing.
- **5.3 Beetham PC casual vacancy (3.1)** as no requests for an election had been received within

the specified time limit, it was now up to the parish council to fill the vacancy by cooption.

A notice had been placed in all parish notice boards inviting applications, with a three-week deadline (17th November). No applications had yet been received, but Cllr Jupe

was

hopeful of identifying possible candidates.

- **5.4 Dispensations (3.2)** the Clerk had received dispensation requests from all members, enabling them to discuss and vote on the parish council's budget/precept for 2013/14. SLDC had indicated there was no need to lodge these requests with them.
- **5.5 Elbourne seat (12)** installation was now satisfactorily completed. CCC had asked for

the

parish council to sign an agreement to maintain and take full future responsibility for the seat. Clerk to check the necessity for, and legal implications of, this and place on agenda for the PC's December meeting. It was suggested that it might be best for the seat to be transferred to PC ownership, if all parties agreed.

6.0 Public Participation.

- **6.1 Police Report** none. The absence of regular reports and of police attendance at PC meetings regarded as unsatisfactory Clerk to advise police accordingly.
- **6.2 County Council matters (Cllr Stewart)** not much to report. A number of political issues

to do with current elections and some £20m savings to be found from CCC's 2013/14 budget.
